### **Site Registration:**

- All you need to participate is a phone or speaker phone.
- A site coordinator from each participating agency must be registered.
- Materials such as the call instructions, roster, handouts, and evaluation links will be sent to each site coordinator 2-3 days prior to the audio conference.
- It is the responsibility of each site coordinator to copy and distribute materials to the additional participants on the call.
- After the completion of the audio conference, the site coordinator is responsible for having all participants sign the roster, and for providing participants with the link to complete the online evaluation form (***a link will be provided to complete the evaluation form using SurveyMonkey***).
- Rosters must be faxed or emailed as outlined on each form.

### **Continuing Education:**

## January 23

### Medication Appropriateness

*Ellen Fulp, PharmD, BCGP, Doctor of Pharmacy, BS Pharmaceutical Science, Clinical Education Coordinator, AvaCare, Inc., Greensboro, NC*

This session will define medication appropriateness and review the importance of having a formal reconciliation process for your organization to reduce patient risks, especially during transitions of care. Additionally, common survey deficiencies involving aspects of drug profiles will be identified and patient cases will be used to highlight nonessential medications and unsafe medication use at end of life.

## February 13

### CMS Emergency Preparedness Rule – Are you Ready?

This presentation will provide an overview of the CMS standards related to non-hospital emergency management programs and provide best practices for conducting risk assessments, developing plans, and conducting exercises. Tips and processes will be shared for addressing the regulation in a hospice organization.

### Bringing Pediatric Hospice Home

The presenters will provide data on where pediatric palliative care and hospice are available and the model for making it available for all kids.

## April 19

### Lessons Learned from the Hospice Compare Implementation

Hospice Compare was launched with the HIS measures in August 2017 amid a swirl of questions and issues. With the expected February addition of the CAHPS measures, hospice providers will again need to adapt to the effects of new publicly reported information. This session will explore lessons learned from the Hospice Compare implementation and refreshes, included measures, and best practices for ensuring measures reflect provider performance.

## May 22

### Aberrant Behaviors: Mitigating Medication Risk in Hospice

Across America, healthcare providers are seeing an increased number of patients and families directly impacted by active or historical substance abuse. End of life care for this population presents a unique set of challenges that requires open, honest and frequent communication between the provider, patient and family. This webinar will examine various screening, prescribing and monitoring tools developed to promote the safe use of restricted medications. In addition, participants will discuss approaches to mitigating medication risk in the setting of aberrant behaviors.

## June 5

### Challenges in Palliative Care Delivery for Heart Failure Patients

This lecture will provide an overview of challenges faced by patients with advanced heart disease at the end of life, and their caregivers, and will provide means to overcome some of those issues. Within heart disease, increased focus will be placed on patients with heart failure.

## July 17

### The Balancing Act of Medication Use at the End of Life

Medication use is an integral part of hospice patient management, with most patients taking several medications upon admission and symptom management being widely achieved through pharmacological interventions. As patients decline, continuation of certain medications is not always beneficial or necessary, and ongoing use can cause adverse events, interact with other medications, worsen discomfort, and increase costs for hospices. As comfort medications are added to the regimen, the burden increases. This session will highlight medication risk versus benefit assessment points and provide participants with more confidence in evaluating medication use and discussing these topics with patients, families, and other healthcare providers.

### National Regulatory and Quality Update

### **Hospice Care Out in the Boundary Lands**

*Scott Janssen, Clinical Social Worker, Hospice & Palliative Care Center of Alamance-Caswell, Burlington, NC*

Many people who are dying, as well as their loved ones, experience what are referred to as transpersonal end of life experiences or “deathbed phenomena.” These include things like Near Death Experiences (NDEs), Deathbed Visions (DBVs) and, among those who are grieving, After Death Communication (ADC). Although these events are often profoundly meaningful to those who have had them, patients may be reluctant to speak openly out of fear of being judged, dismissed or stigmatized. The focus of this presentation will be on identifying the characteristics of NDEs, DBVs, ADC and related phenomenon, as well as their likely impact and estimates of prevalence. Participants will also be given strategies for identifying these patients and for creating safe contexts in which they, and their families, may speak openly if they choose to do so.
